#### COMMITMENT FOR TITLE INSURANCE

Attorneys' Title Guaranty Fund, Inc., an Illinois corporation ("ATG®"), for a valuable consideration, commits to issue its policy or policies of title insurance, as identified in Schedule A, in favor of the Proposed Insured named in Schedule A, as owner or mortgagee of the estate or interest in the land described or referred to in Schedule A, upon payment of the premiums and charges and compliance with the Requirements; all subject to the provisions of Schedules A and B and to the Conditions of this Commitment.

This Commitment shall be effective only when the identity of the Proposed Insured and the Amount of the policy or policies committed for have been inserted in Schedule A by ATG.

All liability and obligation under this Commitment shall cease and terminate six months after the Effective Date or when the policy or policies committed for shall issue, whichever first occurs, provided that the failure to issue the policy or policies is not the fault of ATG.

ATG will provide a sample of the policy form upon request.

This Commitment shall become effective and binding when Schedule A and Schedule B and any endorsements are signed by a title insurance agent or other authorized signatory of ATG.

#### **CONDITIONS**

- 1. The term mortgage, when used herein, shall include deed of trust, trust deed, or other security instrument.
- If the proposed Insured has or acquired actual knowledge of any defect, lien, encumbrance, adverse claim or other matter affecting the estate or interest or mortgage thereon covered by this Commitment other than those shown in Schedule B hereof. and shall fail to disclose such knowledge to ATG in writing, ATG shall be relieved from liability for any loss or damage resulting from any act of reliance hereon to the extent ATG is prejudiced by failure to so disclose such knowledge. If the proposed Insured shall disclose such knowledge to ATG, or if ATG otherwise acquires actual knowledge of any such defect, lien, encumbrance, adverse claim or other matter, ATG at its option may amend Schedule B of this Commitment accordingly, but such amendment shall not relieve ATG from liability previously incurred pursuant to paragraph 3 of these Conditions.
- 3. Liability of ATG under this Commitment shall be only to the named proposed Insured and such parties included under the definition of Insured in the form of policy or policies committed for and only for actual loss incurred in reliance hereon in undertaking in good faith (a) to comply with the requirements hereof, or (b) to eliminate exceptions shown in Schedule B, or (c) to acquire or create the estate or interest or mortgage thereon covered by this Commitment. In no event shall such liability exceed the amount stated in Schedule A for the policy or policies committed for and such liability is subject to the insuring provisions and Conditions and the Exclusions from Coverage of the form of policy or policies committed for in favor of the proposed Insured which are hereby incorporated by reference and are made a part of this Commitment except as expressly modified herein.
- This Commitment is a contract to issue one or more title insurance policies and is not an abstract of title or a report of the condition of title. Any action or actions or rights of action that the proposed Insured may have or may bring against ATG arising out of the status of the title to the estate or interest or the status of the mortgage thereon covered by this Commitment must be based on and are subject to the provisions of this Commitment.
- The policy to be issued contains an arbitration clause. All arbitrable matters when the Amount of Insurance is \$2,000,000 or less shall be arbitrated at the option of either ATG or the Insured as the exclusive remedy of the parties. Defects, liens, encumbrances, adverse claims, or other matters, if any, created, first appearing in the Public Records, or attaching subsequent to the Effective Date hereof but prior to the date the proposed Insured acquires for value of record the estate or interest or mortgage thereon covered by this Commitment.
- 2. Any loan policy issued pursuant to this Commitment will be subject to the following exceptions (a) and (b), in the absence of the production of the data and other matters contained in the ATG ALTA Statement form or an equivalent form:
  - a. Any lien, or right to a lien, for services, labor, or material heretofore or hereafter furnished, imposed by law and not shown by the Public Records;
  - b. Consequences of the failure of the lender to pay out properly the whole or any part of the loan secured by the mortgage described in Schedule A, as affecting: (i) the validity of the lien of said mortgage; and (ii) the priority of the lien over any other right, claim, lien, or encumbrance that has or may become superior to the lien of said mortgage before the disbursement of the entire proceeds of the loan.
- 3. Payment of the full consideration to, or for the account of, the grantors or mortgagors for the estate or interest to be insured.
- 4. Recordation or registration of duly executed and delivered instruments sufficient to create the estate or interest to be insured.
- 5. Taxes for the year 2014 and thereafter.

  - h. Right of Way Easement from Southern Illinois Land Co. Inc. to Southern Illinois Power Cooperative dated August 5, 2008, recorded on August 22, 2008, in Record Book 1942, pages 155- 159.
  - i. Right of Way agreement between Pleas Furlong et ux to Sahara Coal Company, dated November 5, 1947, and recorded November 6, 1947, in Miscellaneous Record Book U at page 598, granting "Sahara Coal Company, its successors and assigns, the right to construct, operate, patrol and maintain an electric transmission line ... to form a part of an electrical transmission and telephone system owned and operated by the Sahara Coal Company, its successors or assigns extending from lands owned by the said Sahara Coal Company to other lands and structures beyond said premises ... " The legal description set forth in the easement is:

- t. Right of Way Easement to the Prospect Water District dated July 9, 1984, recorded on August 15, 1984, in Record Book 590, at page 657.
- u. Right of Way Easement from Sahara Coal Company, Inc., to the Prospect Water District, dated July 9, 1984, recorded on August 13, 1984, in Record Book 590, at page 657 for the construction, operation, and maintenance of a watermain and necessary appurtenances.
- v. A Conservation Easement from Shawnee Holdings, LLC, to Land Conservation Trust of Southern Illinois, dated November 28, 2014, and recorded December 3, 2014, in Book 2086, at pages 916 to 923, in the Office of the Recorder, Saline County, Illinois, granting the perpetual right and exclusive easement to use, monitor and enforce a Conservation Easement pursuant to the Illinois Real Property Conservation Rights Act, 765 ILCS 120.
- w. A Conservation Easement from Shawnee Holdings, LLC, to Land Conservation Trust of Southern Illinois, dated November 28, 2014, and recorded December 3, 2014, in Book 2086, at pages 908 to 915, in the Office of the Recorder, Saline County, Illinois, granting the perpetual right and exclusive easement to use, monitor and enforce a Conservation Easement pursuant to the Illinois Real Property Conservation Rights Act, 765 ILCS 120.
- 9. Consequences, if any, due to failure of patent to be made of record concerning the subject property.
- 10. Consequences, if any, due to failure to obtain a death certificate or affidavit of extinction of life estate for Velma Furlong. By Special Corporate Warranty Deed, dated September 21, 1989, and recorded September 29, 1989, Sahara Coal Company, Inc., conveyed to Velma Furlong, for and during her natural life, a part of the subject property.
- 11. This commitment, and policy when issued, does not cover any loss due to any errors or discrepancies in the Final Title Opinion to Surface from John Rhine, Fowler, Rhine and Ernest, dated September 7, 1990, based upon: Base abstract of title No. R-1648 covering the subject property from sovereignty to May 13, 1955, at 7:00 a.m., as certified by Deister, Ward and Witcher, abstracters, consisting of 225 pages numbered 1 through 225, consecutively, inclusive of the caption, but exclusive of the index and certificate; unnumbered extension of abstract of title covering the subject property, except the coal and other minerals

underlying the surface together with the right to mine and remove the same, from May 13, 1955, at 7:00 a.m., to July 17, 1989, at 7:00 a.m., consisting of 33 pages numbered 1 through 33 consecutively, exclusive of the caption and certificate; unnumbered extension of abstract of title covering the subject property, except the coal and other minerals underlying the surface together with the right to mine and remove the same, from July 17, 1989, at 7:00 a.m., to October 24, 1989, at 7:00 a.m., consisting of 38 pages numbered 1 through 38 consecutively, exclusive of the caption and certificate; facsimile of documents from Case No. 71-TX-102 in the Circuit Court of the First Judicial Circuit, Saline County, Illinois provided by Sahara Coal Company, Inc.; and the following documents appearing in the Matter of the Estate of Pleas Furlong, Sr., deceased, Saline County, probate cause number 62-P-210: Final Account and Report with Proof of Service filed September 13, 1989; Notice of Hearing filed September 13, 1989; Proof of Service filed September 25, 1989; Order declaring Heirship and Order Approving Final Account, Discharging Administrators and Closing Estate dated October 6, 1989.

- 12. A special assessment from the Bankston Drainage District is noted by the abstracter as having been paid for tracts within the subject property. However, no recording information is given. In both instances, the first installment on these payments was due April 1, 1912.
- 13. This commitment, and policy when issued, does not cover any loss due to any errors or discrepancies not indicated in the Title Insurance Policies issued by Lawyers Title Insurance Corporation, Richmond, Virginia, dated December 22, 1994, and December 27, 1994, respectively, covering the subject property.

- 19. Matters affecting title, if any, occurring seventy-five years prior to the effective date of this commitment.

This commitment, and policy when issued, does not cover the accuracy of any survey provided to any party, exact area/acreage recitals concerning the subject property, errors in the legal descriptions of the property, if any, or other matters which would be disclosed by a current and complete survey of the property.
