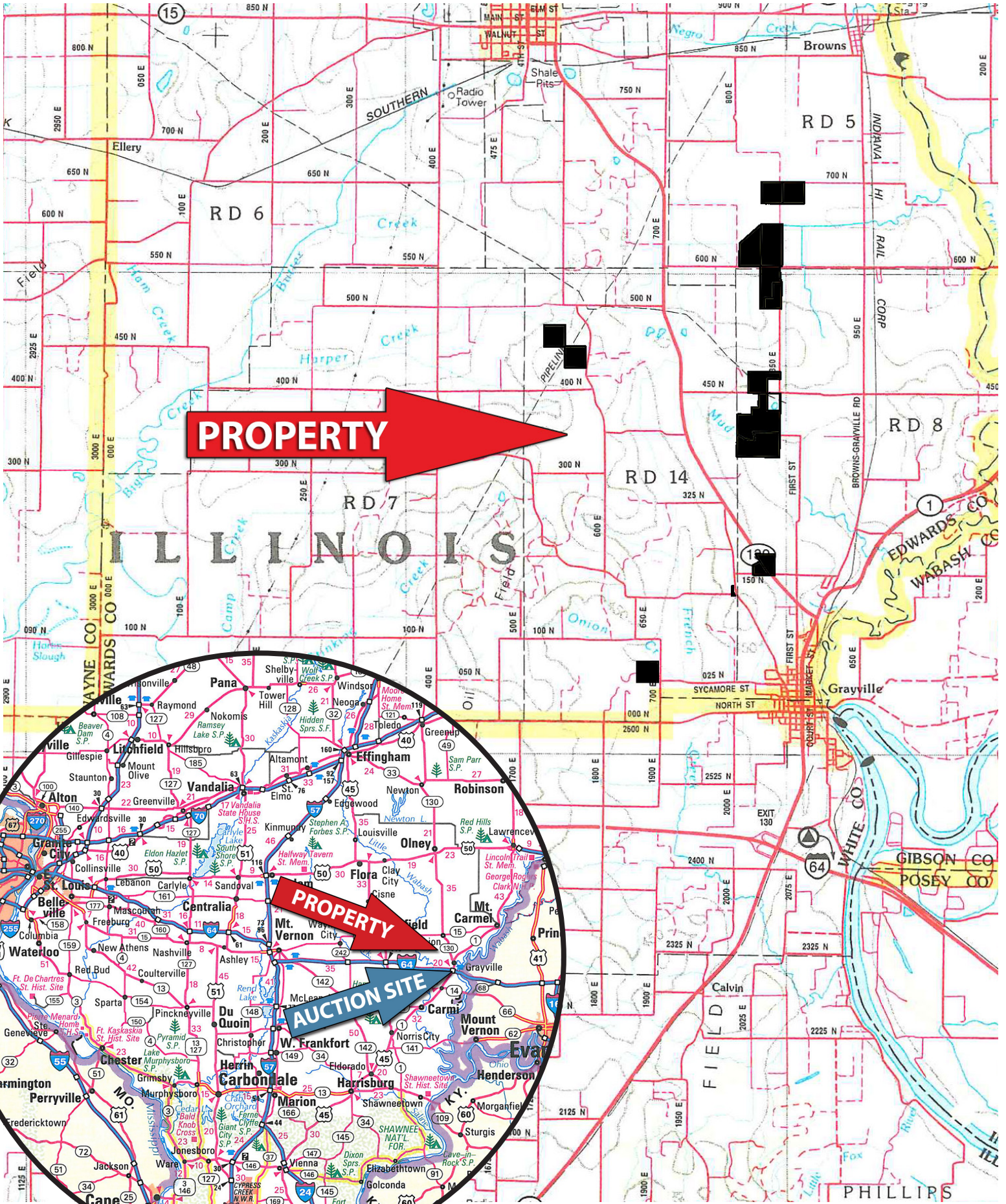

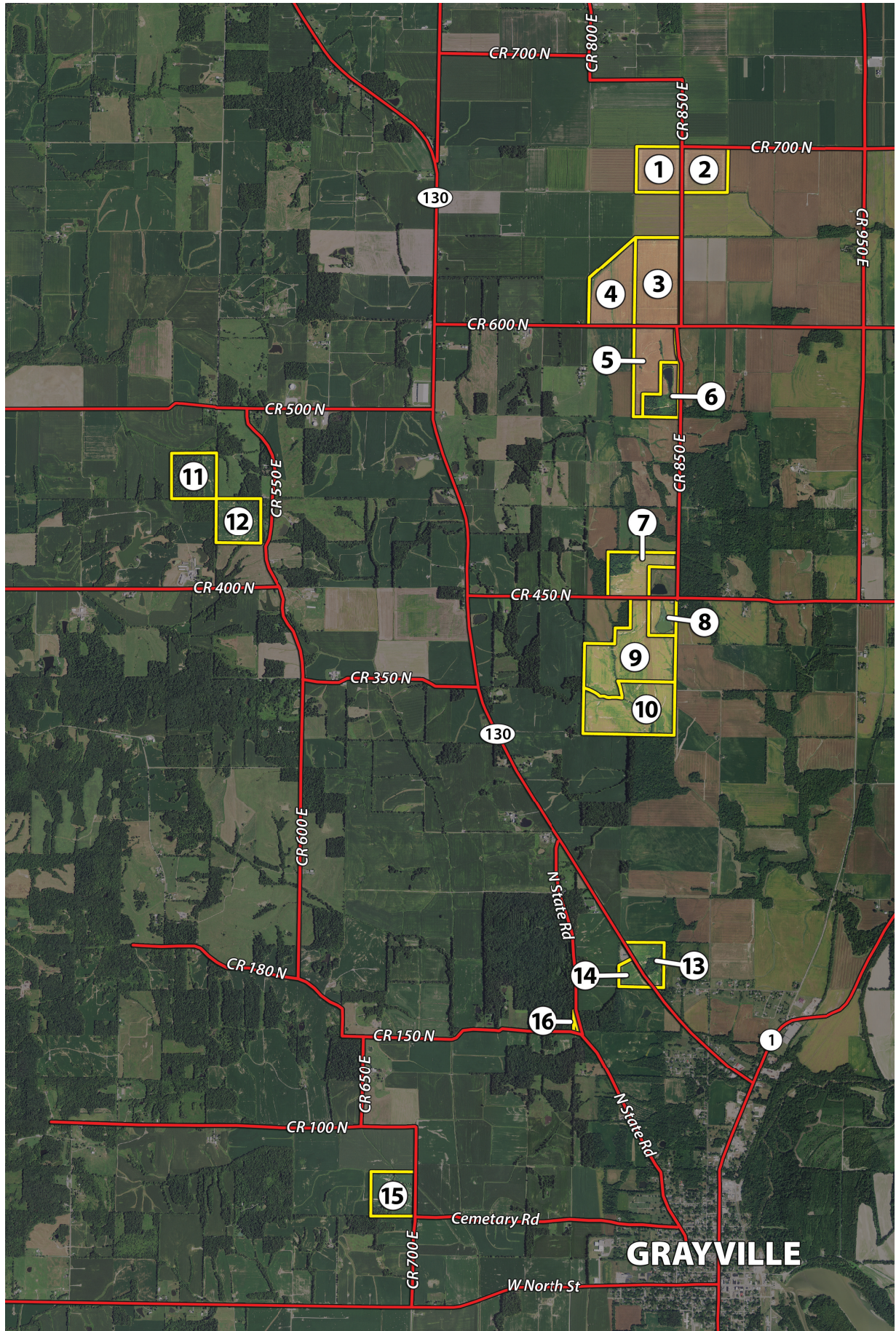

LOCATION MAP



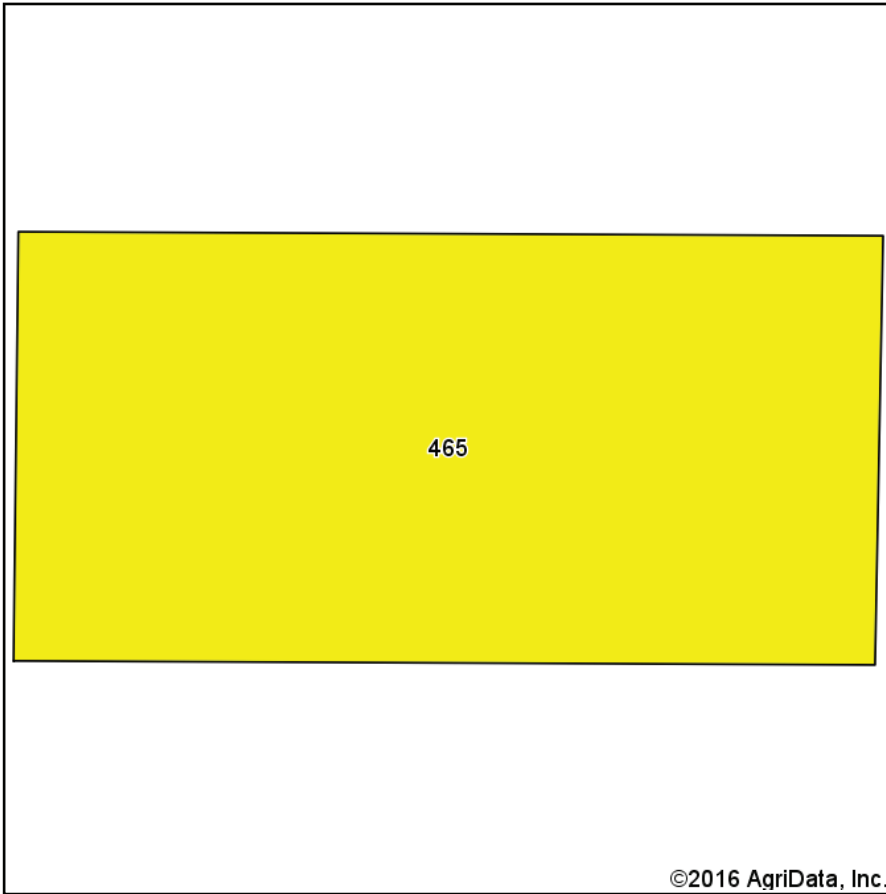

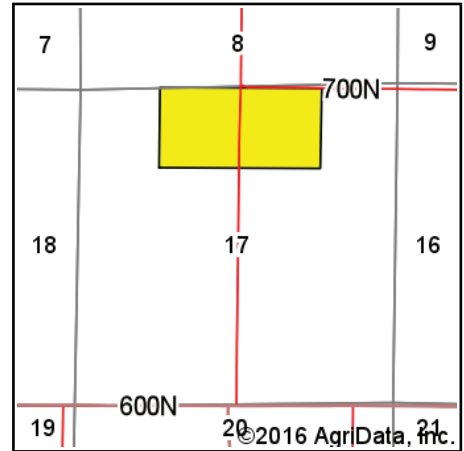

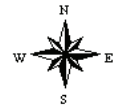
SOIL MAP - TRACTS 3-6

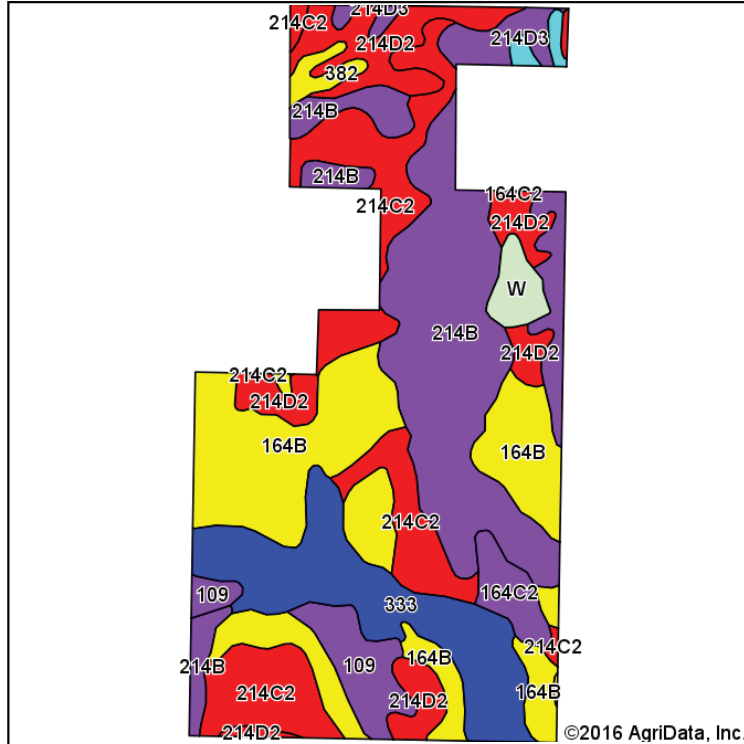

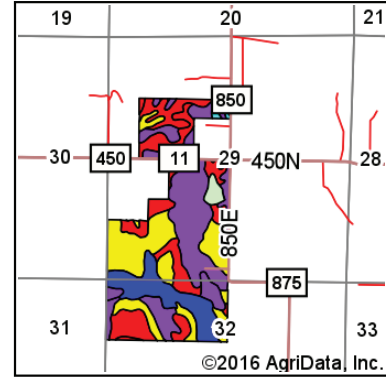

SOIL MAP - TRACTS 7-10



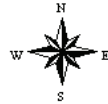

SOIL MAP - TRACTS 13 & 14

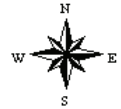

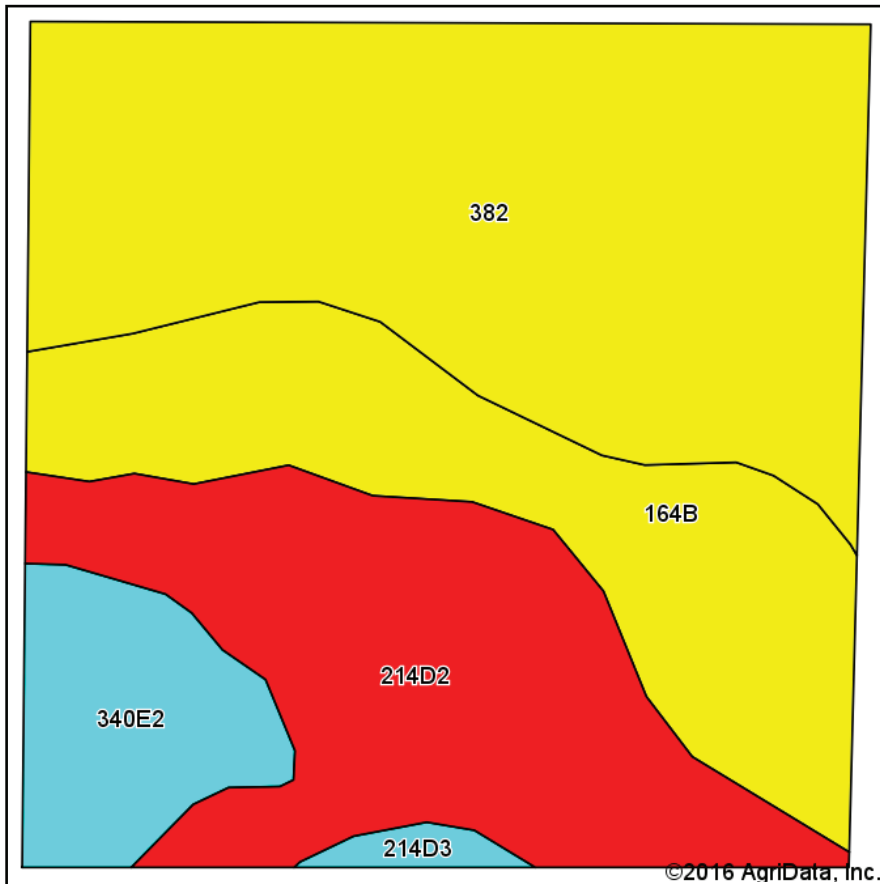

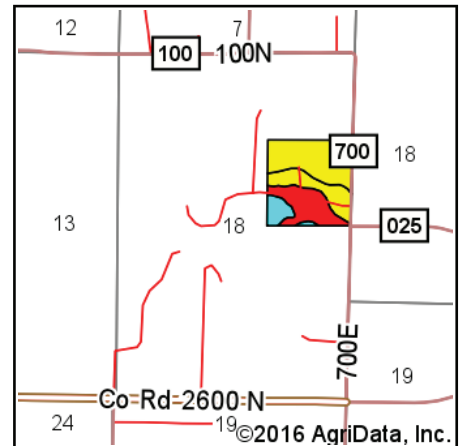

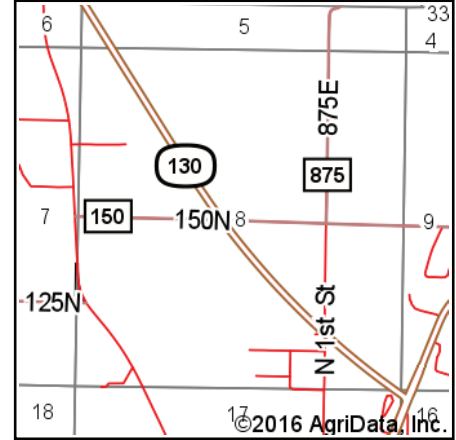

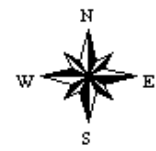
TOPO MAP - TRACTS 7-10

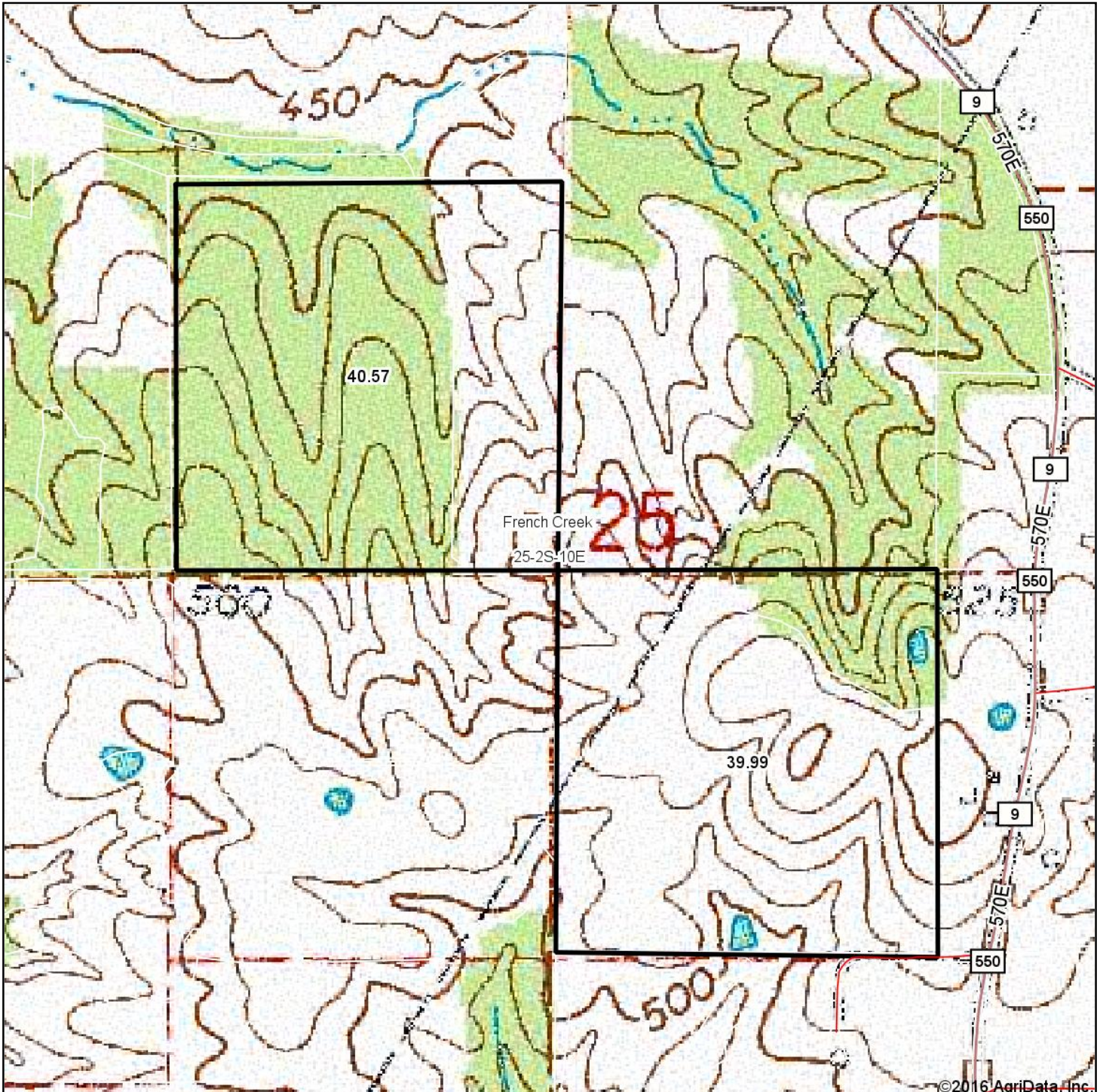

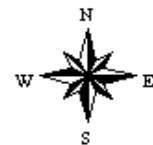

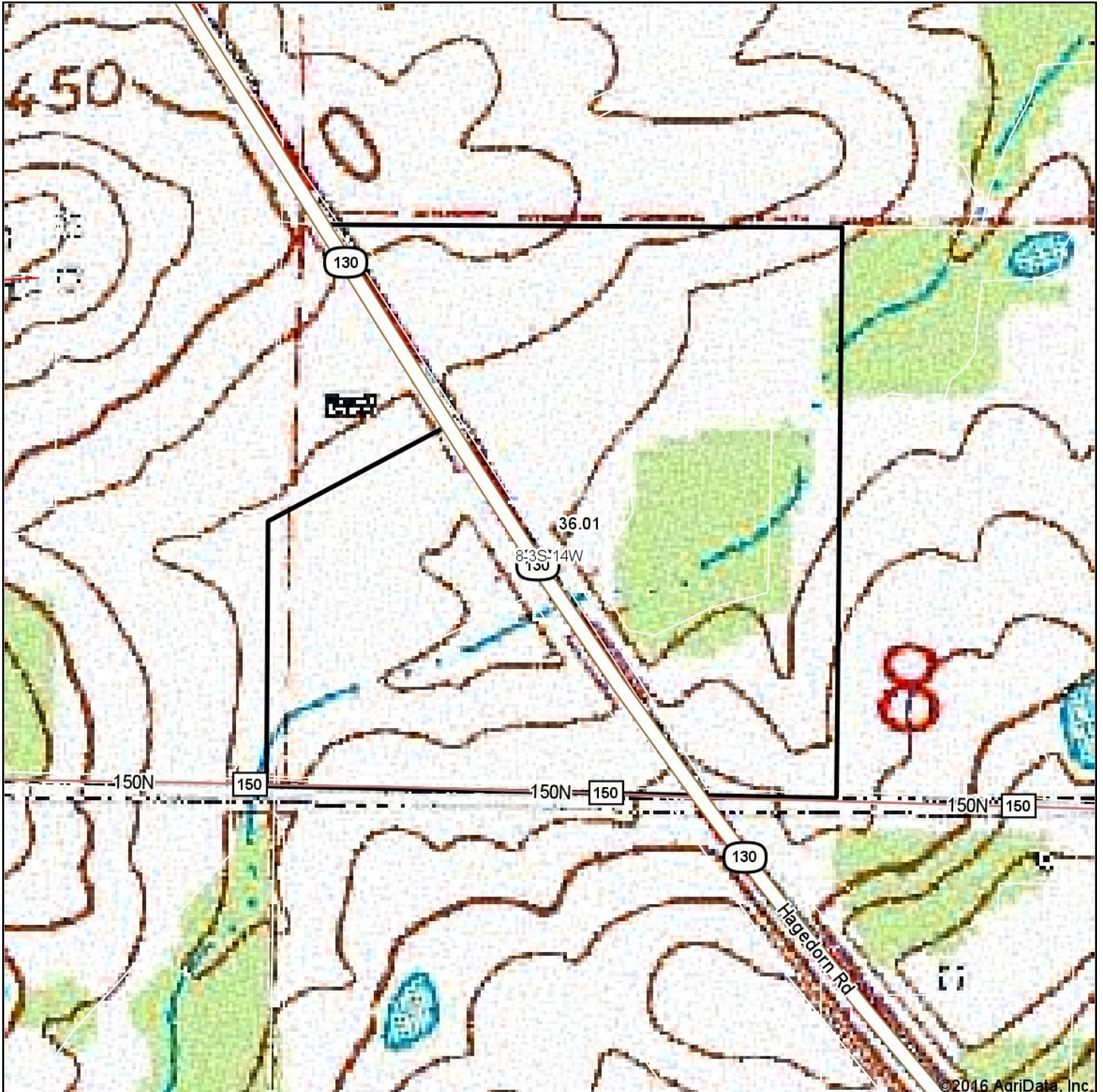

TOPO MAP - TRACTS 13 & 14



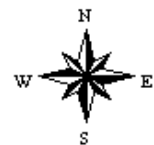
