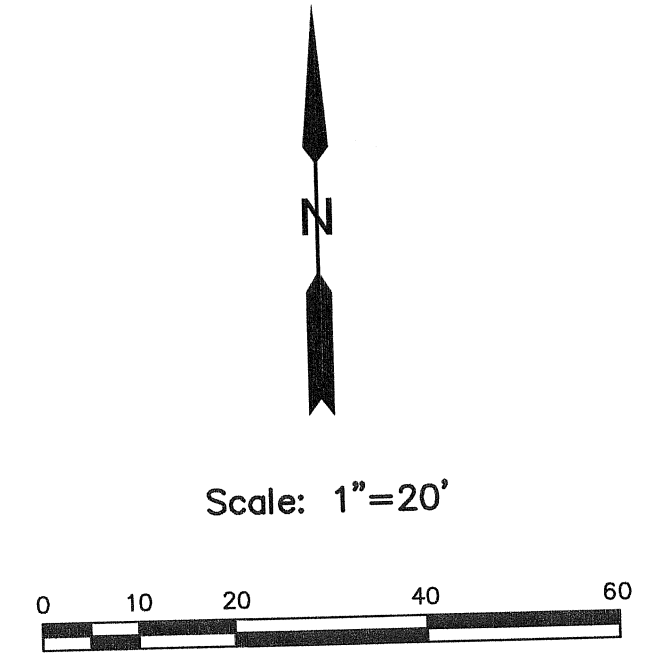
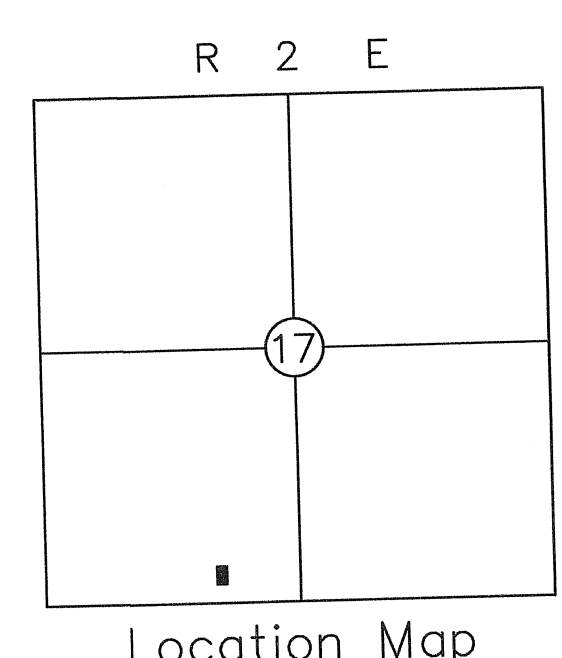
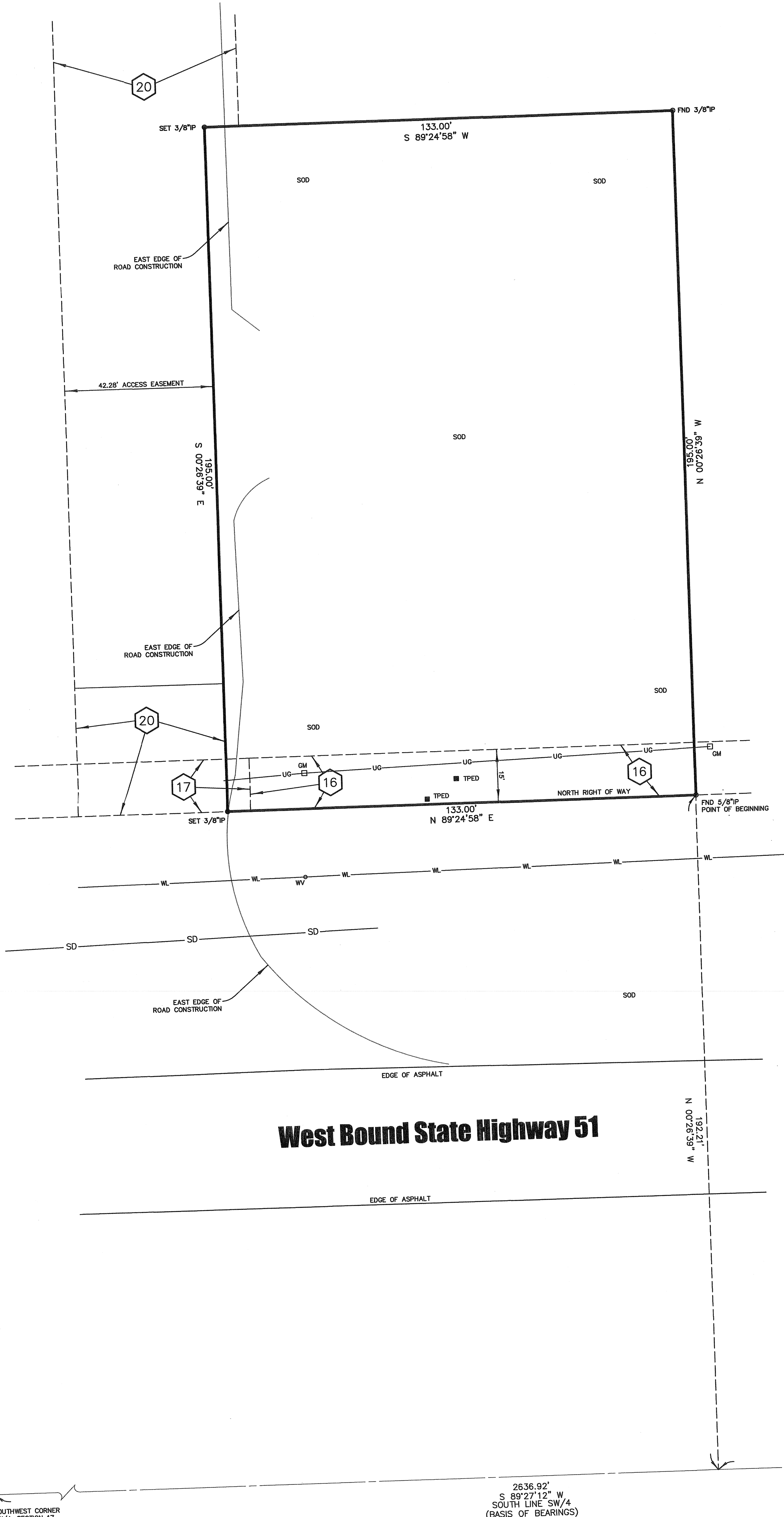


Legal Description
