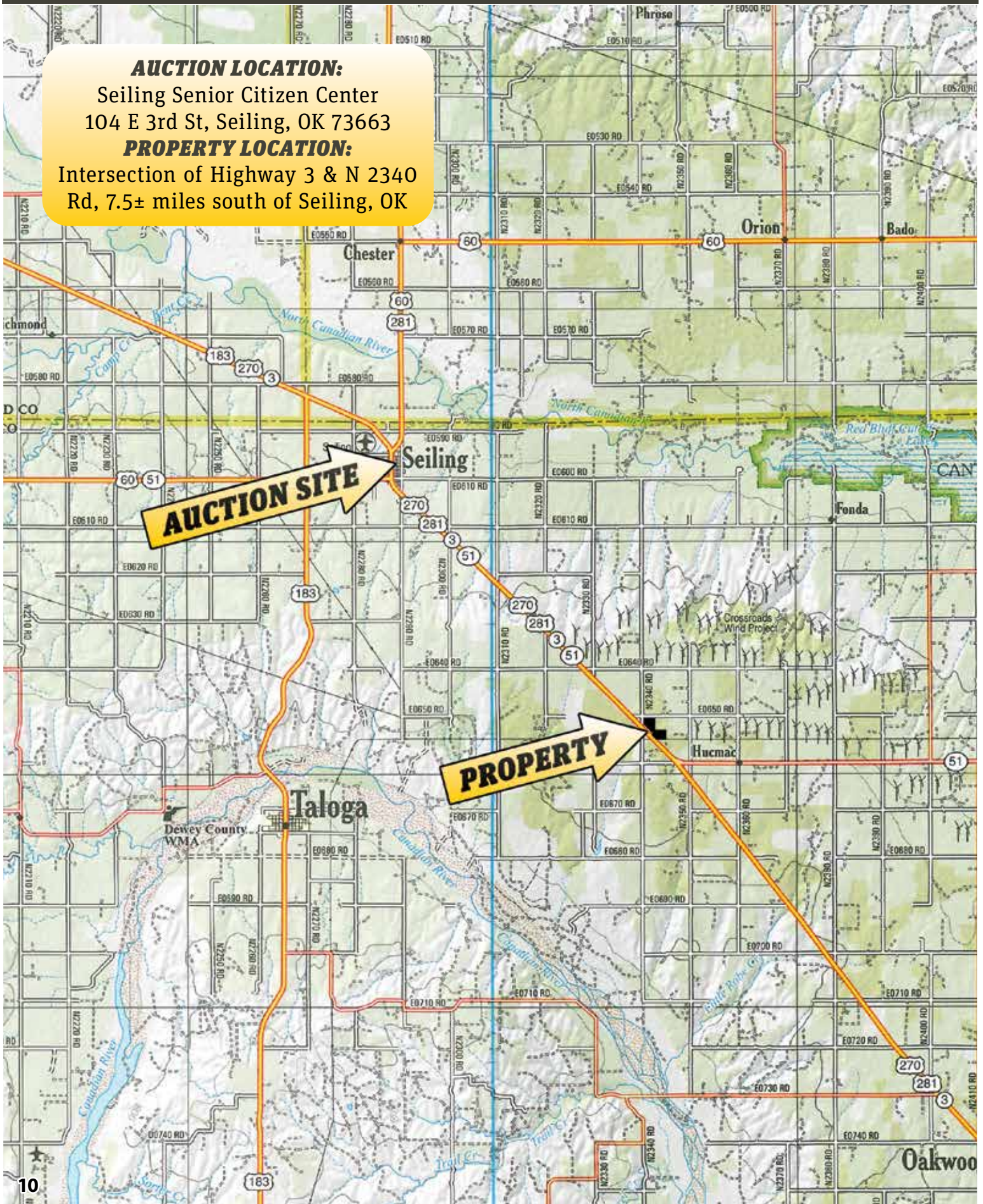

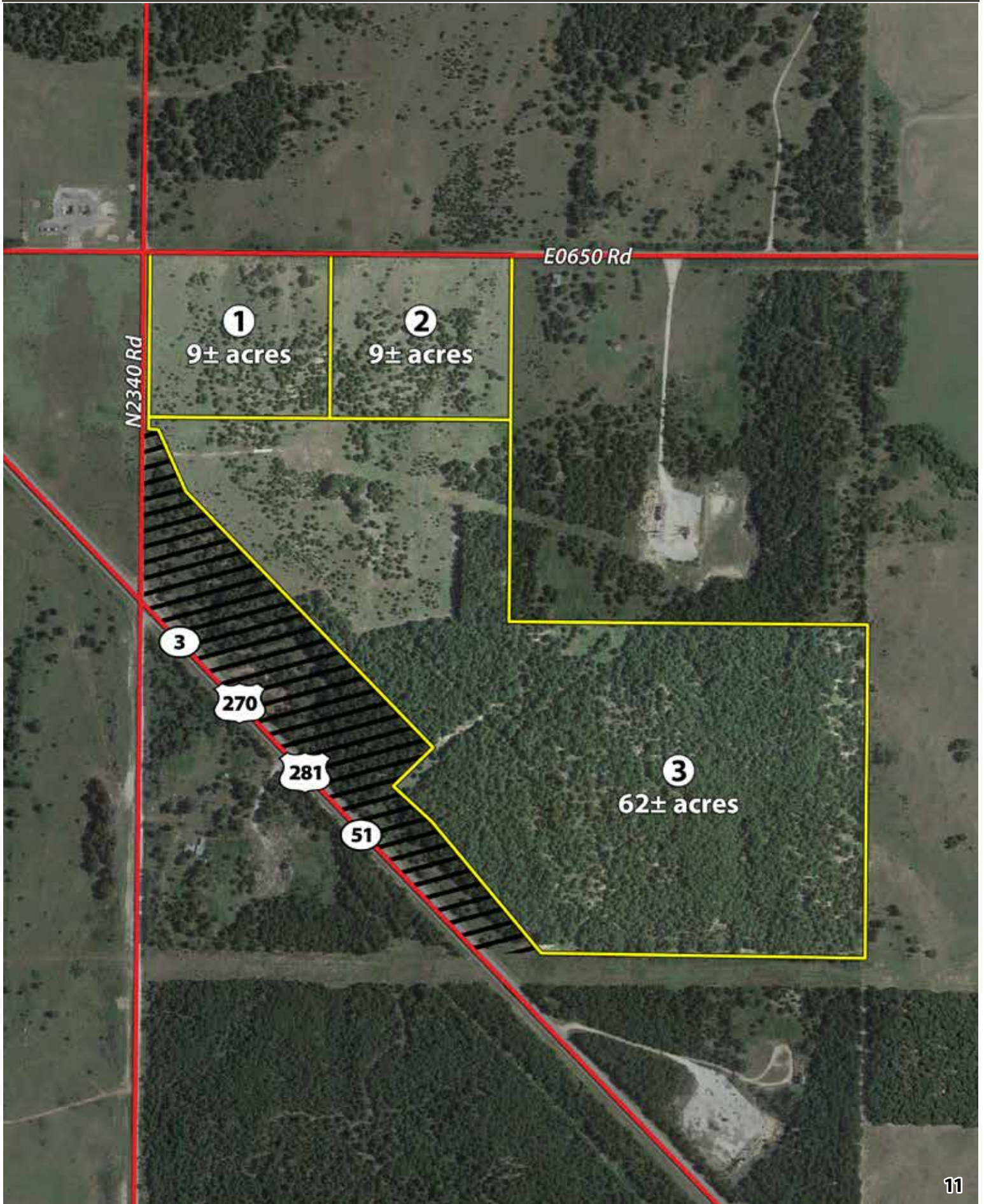

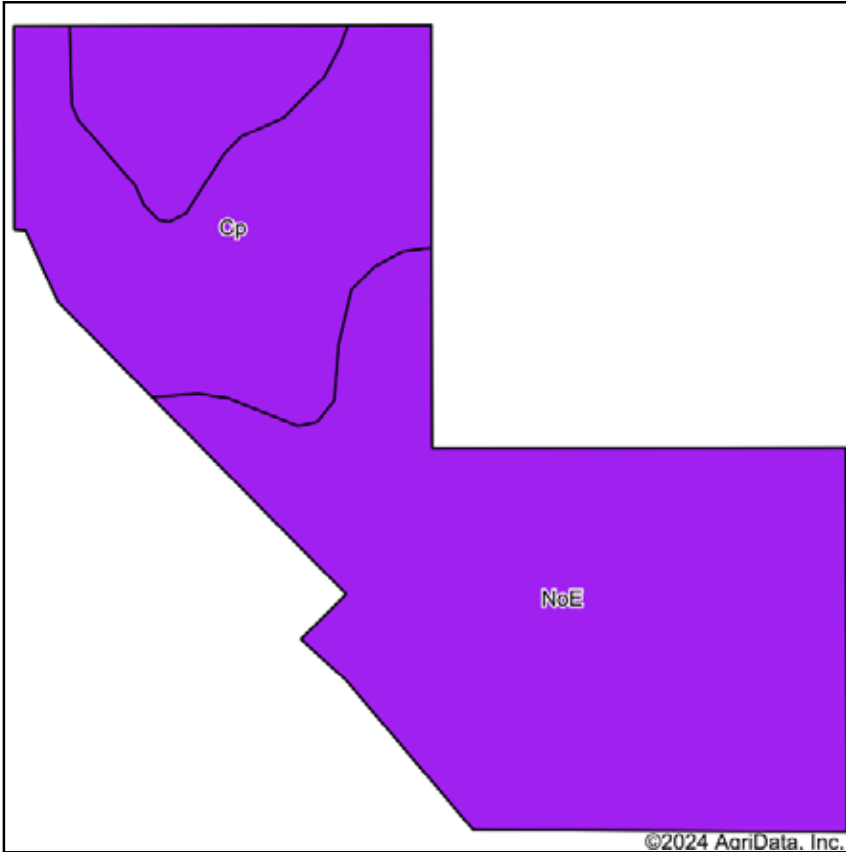


LOCATION & TRACT MAPS

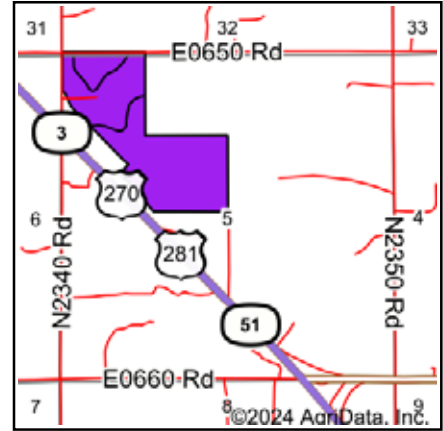


SOILS MAP

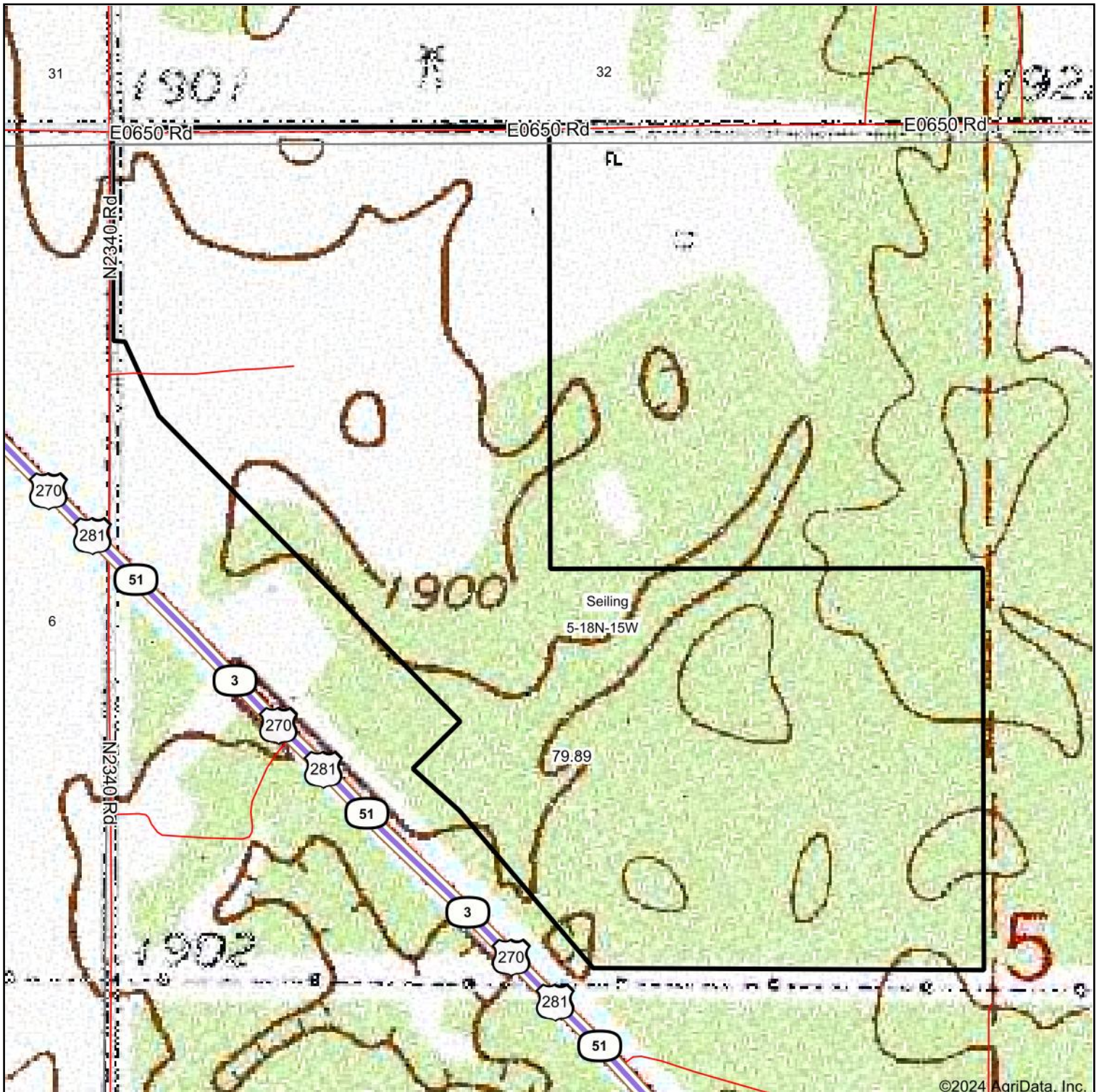

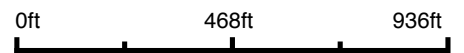

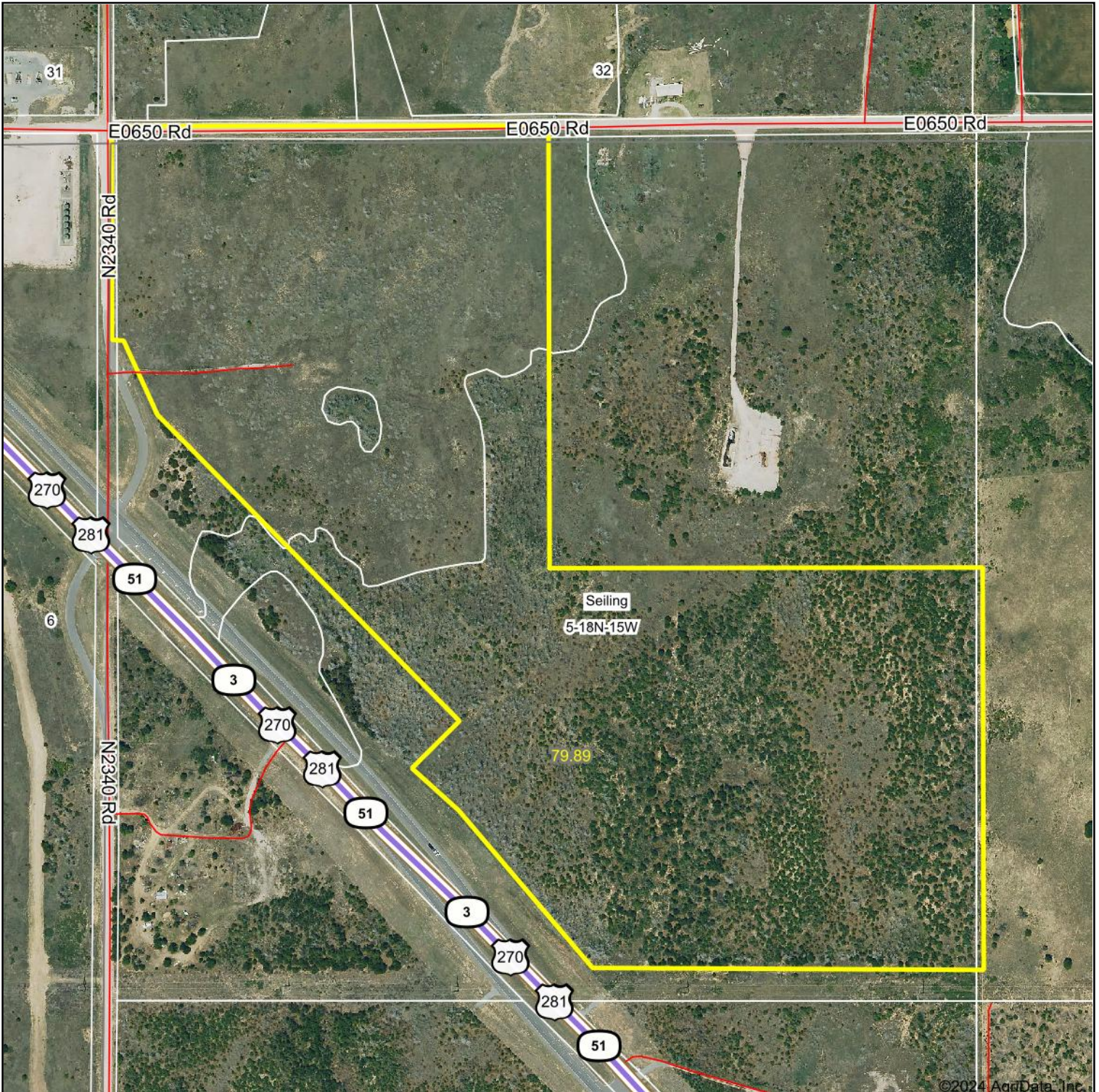
